AGAIN, THESE GRANTS FOCUS ON ECONOMIC SELF-SUFFICIENCY: ONE TRAINS WOMEN TO ACHIEVE CERTIFIED CAREGIVER STATUS, THE OTHER PROVIDES BUSINESS TRAINING AND LOANS TO WOMEN ENTREPRENEURS. SELECTED BY THE ASSOCIATION OF FUNDRAISING PROFESSIONALS AS THEIR 2012 YOUTH PHILANTHROPISTS OF THE YEAR, OUR UNIDAS PROGRAM TRAINED NINETEEN YOUNG TUCSON WOMEN ON SOCIAL JUSTICE ISSUES, PHILANTHROPY, LEADERSHIP AND GRANT-MAKING.
