***Data Reports Registrations***

Registered 1,530,716 items via manufacturers' reposts certifying these items were constructed and/or repaired in accordance with uniform safety standards, the ASME Boiler and Pressure Vessel Code and the National Board Inspection Code, copies of which are made available to National Board members to assist them in their respective duties of enforcement of boiler and pressure vessel safety rules and regulations within their respective jurisdictions. We also supplied 32,045 copies of previously-registered data reports to enable those items to be repaired and/or altered in accordance with uniform safety standards.

***Testing, Reviewing, and Accrediting Quality Control Programs for Compliance with Safety Standards***

We conducted 2,113 tests of safety relief valves, 1,264 reviews of quality control programs, and accredited 1,846 entities for the purpose of assuring compliance with the uniform safety standards of the ASME boiler and Pressure Vessel Code and/or the National Board Inspection Code. We provided over 1,500 copies of the 2011 Edition of the National Board Inspection Code, the safety standard for inspection and repair of boilers and pressure vessels.

***Training and Commissioning of Inspectors in the Requirements of Safety Standards***

We trained over 1,500 students and commissioned 4,000 inspectors in the requirements of the ASME Boiler and Pressure Vessel Code and National Board Inspection Code in an effort to maintain uniform qualifications of inspectors and assurance of compliance with the uniform safety standards of the ASME Boiler and Pressure Vessel Code and the National Board Inspection Code.
