These in-home services last up to 6 months, in DuPage County, Illinois.

Pregnancy Support services:

During FY 2013, 75 women and their families were served during their unplanned pregnancy. Care includes housing, referrals for medical care, professional counseling and support for basic needs. Services are provided free of charge, during and up to 6 months following a pregnancy.
