Marklund currently serves over 190 clients. 117 are residential, and the remaining individuals come from the community to utilize our day programs. Many have complex medical problems that require 24-hour skilled nursing care provided at all of our homes. We have gained the trust of over 1,800 families for the residential and therapeutic needs for their children, and we continue to be a premier provider of these individualized services. Recently, we opened a life skills classroom at our Bloomingdale location to serve students with autism. Our Community programs include Developmental training, Respite, and Early Intervention for children up to 3 years old.
