


THE BOARD OF MAOT CHITIM OF GREATER CHICAGO (ORGANIZATION) IS RESPECTFULLY REQUESTING ABATEMENT OF PENALTIES FOR THE LATE FILING OF ITS 2012 FORM 990.

THE ORGANIZATION UNDERSTANDS ITS FIDUCIARY AND FILING RESPONSIBILITIES AND TAKES THEM SERIOUSLY. IN 2013, THE ORGANIZATION LEARNED THAT ITS EXEMPT STATUS HAD BEEN REVOKED DUE TO NON-FILING OF FORMS 990 FOR THREE YEARS. AS THE NOW FORMER EXECUTIVE DIRECTOR (THE ORGANIZATION'S ONLY EMPLOYEE) HAD INFORMED THE BOARD ON AN ONGOING BASIS THAT SUCH FORMS HAD BEEN FILED, THE BOARD TOOK A CLOSER LOOK AT THE FINANCIAL ACTIVITIES AND DETERMINED THAT MANY MEASURES NEEDED TO BE TAKEN, INCLUDING A CHANGE IN BOTH THE STAFF AND OUTSIDE ACCOUNTING FIRM. THE NEW ACCOUNTING FIRM BEGAN ITS AUDIT FOR THE YEAR ENDED JUNE 30, 2013, AND FULLY EXPECTED TO BE ABLE TO COMPLETE THE AUDIT AS WELL AS THE FORM 990 ON A TIMELY BASIS BY THE FINAL EXTENDED DUE DATE OF THE RETURN OF MAY 15, 2014. BECAUSE THE BOARD WANTED THE FINANCIAL RECORDS TO BE AS ACCURATE AS POSSIBLE, IT WAS DETERMINED THAT THE 990 WOULD NOT BE FILED UNTIL SUCH INFORMATION WAS AVAILABLE. THIS WAS, UNFORTUNATELY, AFTER THE EXTENDED DUE DATE OF THE RETURN. AS SOON AS THE AUDIT WAS FINISHED THE RETURN WAS COMPLETED, SUBMITTED TO THE BOARD, AND FILED. THE AUDIT FOR THE YEAR ENDED JUNE 30, 2014 IS SET TO BEGIN SHORTLY, WITH COMPLETION OF THE 2013 FORM 990 TO FOLLOW IMMEDIATELY THEREAFTER.

THE ORGANIZATION HAS TAKEN NUMEROUS STEPS TO ENSURE WE WILL BE ABLE TO COMPLY WITH ALL REQUIRED IRS FILINGS GOING FORWARD, INCLUDING THE FOLLOWING:

1. THE ORGANIZATION HAS RETAINED THE ACCOUNTING FIRM OF MANN WEITZ & ASSOCIATES OF DEERFIELD, ILLINOIS. IN ADDITION TO HELPING PREPARE FILINGS, THEY HAVE ASSISTED IN DEVELOPING POLICIES AND PROCEDURES THAT WILL SAFEGUARD THE ORGANIZATION'S EFFORTS IN THE FUTURE. 3. THE ORGANIZATION HAS REPLACED THE EXECUTIVE DIRECTOR WITH COMPETENT STAFF.

4. THE ORGANIZATION RETAINED THE SERVICES OF A PART-TIME BOOKKEEPER TO ASSIST THE EXECUTIVE DIRECTOR WITH FINANCIAL REPORTING.

IN SUMMARY, THE BOARD HAS TAKEN SIGNIFICANT STEPS TO ENSURE COMPLIANCE WITH ALL FINANCIAL REPORTING REQUIREMENTS, INCLUDING FILING OF TAX FORMS. A SIGNIFICANT INVESTMENT IN MONEY AND BOARD TIME HAS BEEN MADE


