NMHCF accomplishes this by 1) stimulating the community in the development of Northern Montana Hospital (NMH), 2) assisting in the public relations of NMH, specifically in improving the financial support from contributors, 3) coordinating NMH fundraising programs.

	The Foundation raises funds to give to the Hospital which uses the money to help cover operating costs associated with delivering patient care. In the Fiscal Year 2013, the Foundation raised funds through their annual Benefit Wine Gala and Golf Tournament to be used for future projects. The Foundation also supported the Havre Women Against Breast Cancer golf tournament, which raised funds to provide mammograms, wigs and travel assistance to women fighting breast cancer. The Foundation participates in the "Men Who Cook for Women Who Wine" fundraiser. Monies raised are given to the Foundation to disburse to individuals in need of travel assistance for serious medical conditions. With the support of the Foundation, a new Cancer Center was built and opened in 2008. Funds raised during the Capital Campaign are still being disbursed to assist the Hospital with making loan payments on the building. The Center has been served residents of Havre and the surrounding hi-line communities. Patients diagnosed with cancer no longer have to drive 220 miles round trip to receive treatment. The Hi-Line Sletten Cancer Center (HSCC), located in Havre, Montana gives all hi-line families first class cancer care, at home. There are more than 35,000 individuals who live in the service area, which extends along the northern tier of Montana from Chester to Glasgow. Health officials estimate more than 220 of our friends, neighbors and loved ones in this area will be newly diagnosed with cancer each year. In March of 2012 Cancer services at the Hi-Line Sletten Cancer Center were suspended due to loss of an Oncology physician. Recruitment efforts are under way and once a new Oncologist is found, operations will resume. To date, four oncologists have visited the site, but sadly none have been successfully recruited.
