29 Peace Activism The Peace Center hosted Paul Chappell, an Iraq Veteran and Nationally acclaimed speaker in September 2012 for an evening lecture to over 200 people and a day-long Peace Leadership workshop for 12 people. Due to popular demand, he was brought back for a return lecture in April 2013. The Peace Center hosted an ongoing discussion group on Inter cultural dialog attended monthly by 12 people and looking at discussions of China, Brazil, India, German and many other cultures. The Peace Center hosted David Barsamian, producer of Alternative Radio to Missoula for a community lecture to 150 people. The Peace Center conducted their annual youth search for peace art contest with over 60 entries from local youth and had an award event with local celebrities for entrants and their families. The Peace Center's peace knitting group made 30 teddy bears for children in Burma, 17 hats for homeless veterans and many squares sent to Zambia to make quilts for orphans.
