Per IRS guidelines, the present value of the annuity is taxable the year in which vesting occurs. On a cash basis, Dr. Nasatir did not receive any payments from this arrangement in 2012. The \$50,000 and \$5,000 annual payment amounts are to be adjusted annually in accordance with the CPI index. These benefits are payable to him only for as long as he lives. There are no guaranteed payment amounts and no survivor benefits at his death. In 2012, Steven Nasatir received payments of \$68,832 from the first supplemental non-qualified retirement plan, David Rosen. The Jewish Federation has an agreement with David Rosen which provides for annual payments of \$25,000 per year beginning in 2018 and lasting for ten years. |
