The Hope Chest, Inc. raises money to be used in support of local programs for women and their children who are fleeing family violence.

Part III - Line 28 - Statement of Program Service Accomplishments:

Through the operation of a thrift shop, The Hope Chest, Inc. provides funding to the Constance Morris House ("CMH"), a domestic violence shelter and branch of Pillars. The thrift shop also uses its profits to purchase meals, clothing and household items for CMH as needed, and pays certain utility bills for CMH as requested. CMH is an emergency residential shelter for women and children fleeing family violence.

The shelter provides a clean, safe and quiet environment that allows a woman to think through her problems and assess possible solutions. The shelter can accommodate 25 women and children at any given time. The shelter also has a 24-hour crisis line and offers non-residential services, such as counseling, support groups, education about family violence for children and court advocacy through its parent charity, Pillars. There are no fees for CMH services. In the fiscal year ended June 30, 2013, The Hope Chest, Inc. granted and paid \$60,000 cash to CMH, purchased and delivered \$287 in meals and \$5,610 in clothing and household goods to CMH, and made \$1,346 in utility payments for CMH.
