Artistic - Produce, Promote and Perform Ballets During The Joffrey Ballet's 2012 - 2013 Season, the company presented four programs: a mixed repertory program, Human Landscapes (October 2012, 10 performances), Robert Joffrey's The Nutcracker (December 2012, 22 performances), a mixed repertory program, American Legends (February 2013, 10 performances), and Lar Lubovitch's Othello (April/May 2013, 10 performances). The total attendance for these programs was 84,094. Additional performances in Chicago included the Chicago Dancing Festival (August 2012, 1 performance) and the Spring Gala performance (April 2013, 1 performance). Total attendance for these events was approximately 15,000. The Joffrey Ballet's student matinee series offered The Nutcracker to Chicago Public School students for a discounted ticket rate of \$10. Approximately 2,830 students attended The Nutcracker (December 2012, 1 performance). The Joffrey Ballet toured to 22 cities, presenting The Nutcracker and mixed repertory programs. Approximately 72,355 people attended 40 performances in cities throughout the United States.

In addition, these programs help build a strong dance foundation by focusing on correct posture, placement, coordination, strength, flexibility and musicality. By providing this service to disadvantaged youth, we hope to increase the level of awareness of this art form, and instill life skills that last long after programs end.
