LOCATED IN CHITTAGONG, BANGLADESH, THE ASIAN UNIVERSITY FOR WOMEN (AUW) IS BASED ON THE FIRM BELIEF THAT HIGHER EDUCATION PROVIDES A CRITICAL PATHWAY TO LEADERSHIP DEVELOPMENT, ECONOMIC PROGRESS, AND SOCIAL AND POLITICAL EQUALITY. THE UNIVERSITY EDUCATES PROMISING YOUNG WOMEN FROM DIVERSE CULTURAL, RELIGIOUS, ETHNIC AND SOCIO-ECONOMIC BACKGROUNDS FROM ACROSS SOUTH AND SOUTH EAST ASIA AND THE MIDDLE EAST-WITH A PARTICULAR EMPHASIS ON THE INCLUSION OF WOMEN FROM POOR, RURAL, AND REFUGEE POPULATIONS. AT THE HEART OF THE UNIVERSITY'S MISSION IS THE CIVIC AND ACADEMIC GOAL TO CULTIVATE SUCCESSIVE GENERATIONS OF WOMEN LEADERS WHO POSSESS THE INTELLECTUAL AND PERSONAL SKILLS AND RESOURCES TO ADDRESS THE CHALLENGES OF THEIR COMMUNITIES' SOCIAL AND ECONOMIC ADVANCEMENT. THE ASIAN UNIVERSITY FOR WOMEN SUPPORT FOUNDATION (AUWSF), INCORPORATED AS A NON-PROFIT ORGANIZATION BASED IN THE UNITED STATES, SERVES AS THE PLANNING AND FUNDRAISING ORGANIZATION FOR THIS EFFORT.

FIRST GRADUATIONON MAY 18, 2013, THE ASIAN UNIVERSITY FOR WOMEN GRADUATED ITS FIRST CLASS OF 132 UNDERGRADUATES. AN IMPORTANT MILESTONE FOR THE UNIVERSITY, THE FIRST COMMENCEMENT CEREMONY INCLUDED REMARKS BY GUEST SPEAKER MS. MARINA MAHATHIR, MALAYSIAN WRITER, BLOGGER, AND ACTIVIST AND MEMBER OF AUW'S INTERNATIONAL COUNCIL OF ADVISORS. THE CEREMONY WAS HELD AT THE CHITTAGONG BOAT CLUB, IN CHITTAGONG, BANGLADESH. AUWS FIRST GRADUATION MARKS THE CULMINATION OF YEARS OF HARD WORK BY STUDENTS, FACULTY, ADMINISTRATORS, AND SUPPORTERS. STUDENTS ARE ATTENDING GRADUATE SCHOOLS IN THE UK, ITALY, SRI LANKA, AND CAMBODIA, AND HAVE OBTAINED JOBS IN THE PUBLIC, PRIVATE, AND NON-PROFIT SECTORS IN MANY OF THEIR HOME COUNTRIES. FACULTY AND ADMINISTRATIONAUW STRENGTHENED ITS LEADERSHIP AND WELCOMED 15 NEW FACULTY MEMBERS IN THE 2012-13 ACADEMIC YEAR. THE NEW FACULTY CAME TO AUW FROM AUSTRALIA, EUROPE, NORTH AMERICA, AND OF COURSE, ASIA, FROM INSTITUTIONS SUCH AS THE UNIVERSITY OF OXFORD (UK), HARVARD UNIVERSITY (US), THE UNIVERSITY OF NEWCASTLE (AUSTRALIA), AND THE UNIVERSITY OF JADAVPUR (INDIA). THEY WILL TEACH IN DISCIPLINES RANGING FROM COMPUTER SCIENCE AND ENVIRONMENTAL CHEMISTRY TO CULTURAL STUDIES. MS. REBECCA HARTMANN HAS JOINED THE UNIVERSITY AS THE DEAN OF STUDENTS, COMING TO AUW FROM THE UNIVERSITY OF ILLINOIS (USA) WHERE SHE SERVED AS THE DIRECTOR OF COMMUNITY LIFE AND TENANT SERVICES. INTERNSHIP PROGRAMIN JULY AND AUGUST 2012, A TOTAL OF 135 STUDENTS INTERNEED WITH 52 DIFFERENT COMPANIES, ORGANIZATIONS, AND GOVERNMENT AGENCIES AROUND THE WORLD. THIS MARKED THE THIRD YEAR OF AUWS INTERNSHIP PROGRAM, WHICH HELPS STUDENTS TO GAIN PROFESSIONAL EXPERIENCE, MAKE CONNECTIONS WITH MENTORS, EXPLORE CAREER PATHS, AND APPLY THEIR KNOWLEDGE AND SKILLS TO REAL-WORLD SITUATIONS. INTERNSHIP SITES FOR SUMMER 2012 INCLUDED STARBUCKS (USA), JKSK (EMPOWERING WOMEN, EMPOWERING SOCIETY JAPAN), THE AFGHAN MINISTRY OF COUNTER NARCOTICS (AFGHANISTAN), THE WORLD BANK (BANGLADESH), CLIFFORD CHANCE (INDIA), AND STANDARD CHARTERED BANK (SRI LANKA). SEVERAL 2013 GRADUATES HAD INTERNSHIP EXPERIENCES THAT EXPANDED INTO JOB OPPORTUNITIES FOR THEM AFTER GRADUATION. AFTER A SUCCESSFUL INTERNSHIP WITH A NON-PROFIT ORGANIZATION CALLED PEPY (PROMOTING EDUCATION, EMPOWERING YOUTH), DUTH KIMSRU HAS RETURNED TO HER NATIVE CAMBODIA TO WORK FOR PEPY, HELPING HIGH SCHOOL STUDENTS TO PLAN FOR THEIR FUTURES. SIMILARLY, RECENT GRADUATE ZISHRAT HASAN IS WORKING AS A HEALTH, ENVIRONMENT AND SAFETY SPECIALIST FOR CHEVRON IN BANGLADESH AFTER INTERNING WITH THEM AS AN UNDERGRADUATE. STUDENT RECRUITMENT AND ADMISSIONSIN RECRUITING FOR THE 2013-14 ACADEMIC YEAR, WE FOCUSED ON EXPANDING TO INCLUDE STUDENTS FROM SYRIA, PALESTINE, MALAYSIA, AND INDONESIA. EXPANDED RECRUITMENT BRINGS THE TOTAL NUMBER OF COUNTRIES REPRESENTED AT AUW TO 15: AFGHANISTAN, BANGLADESH, BHUTAN, CAMBODIA, CHINA, INDIA, INDONESIA, MALAYSIA, MYANMAR, NEPAL, PAKISTAN, PALESTINE, SRI LANKA, SYRIA, AND VIETNAM. CONFERENCES AND SPECIAL PROGRAMSIN AUGUST 2012, 43 AUW STUDENTS GATHERED FOR TWO WEEKS TO EXPLORE POSSIBILITIES FOR WOMENS LEADERSHIP IN A REGION WHERE THEY ARE OFTEN DISCRIMINATED AGAINST AND DENIED OPPORTUNITIES. SPONSORED BY THE UNITED STATES DEPARTMENT OF STATE, AUWS SUMMER INSTITUTE WAS A TWO-WEEK PUBLIC SERVICE AND LEADERSHIP TRAINING PROGRAM DEDICATED TO STRATEGY AND SOLUTIONS FOR THE MOST PRESSING SOCIETAL CONCERNS, AND THE PUBLIC SECTOR. ROLES THAT THE WOMEN OF ASIA WILL TAKE ON IN TACKLING THEM. THE CURRICULUM WAS DEVELOPED AND TAUGHT BY DR. RANGITA DE SILVA DE ALWIS (HEAD OF THE GLOBAL WOMENS LEADERSHIP INITIATIVE AT THE WOODROW WILSON CENTER FOR INTERNATIONAL SCHOLARS). THE STUDENTS LEFT THE INSTITUTE WITH TANGIBLE SKILLS AND HANDS-ON EXPERIENCES APPLYING THEM TO REAL-WORLD SITUATIONS. STARTING IN JUNE 2013, MORE THAN 30 STUDENT PARTICIPANTS RETURNED TO THEIR HOME COUNTRIES TO IMPLEMENT THEIR OWN WOMEN IN PUBLIC SERVICE PROJECTS, WHICH RANGED FROM ADVOCACY CAMPAIGNS AGAINST CHILD MARRIAGE IN AFGHANISTAN TO HIGH SCHOOL SEMINARS ON WOMENS LEADERSHIP IN BANGLADESH. THESE PROJECTS ENABLED STUDENTS TO MAKE IMMEDIATE USE OF WHAT THEY LEARNED DURING THE SUMMER INSTITUTE. AT AUW SEPTEMBER 2012 SAW THE FIRST GRASSROOTS WOMENS POLITICAL LEADERSHIP FORUM, ALSO HOSTED AT AUW IN COLLABORATION WITH THE U.S. STATE DEPARTMENT. THE FORUM BROUGHT TOGETHER OVER 100 PARTICIPANTS, TRAINERS, AND SPEAKERS FROM THROUGHOUT AFGHANISTAN, BANGLADESH, INDIA, NEPAL, PAKISTAN, AND SRI LANKA. THE 10-DAY TRAINING PROGRAM PROVIDED WOMEN GRASSROOTS POLITICAL LEADERS WITH THE TOOLS TO BETTER THEIR SOCIETIES AS PUBLIC SERVANTS. SESSION TOPICS INCLUDED PUBLIC SPEAKING, FAIR ELECTIONS, POLITICAL PARTIES, COMMUNICATION SKILLS, ECONOMIC EMPOWERMENT, COALITION BUILDING, AND CONFLICT MANAGEMENT. THE FORUM CONCLUDED WITH EACH DELEGATION DRAFTING AN ACTION PLAN TO IMPROVE WOMENS NETWORKING AND EMPOWERMENT IN THEIR OWN COUNTRY'S UNIQUE CONTEXT.
