THE FOUNDATION'S MONTHLY BOOK TRANSACTIONS REPORT BEGINNING AND ENDING CASH ON THE BASIS OF "CASH IN BANK". OUTSTANDING CHECKS ARE IGNORED. FOR TAX PURPOSES, AT THE END OF EACH JUNE 30<sup>TH</sup> FISCAL YEAR, CASH PER BOOKS IS REDUCED BY ANY OUTSTANDING CHECKS. THAT ADJUSTED AMOUNT IS ALSO SHOWN AS THE BEGINNING CASH FIGURE AT THE START OF THE TAX RETURN FOR THE FOLLOWING FISCAL YEAR

TWO PAYMENTS ON A MONTHLY PRINTOUT FOR JUNE, 2013 WERE LABELED "ASSET MANAGEMENT CHECKS" IN THE TOTAL AMOUNT OF \$35,000. THESE PAYMENTS WERE TREATED AS "MANAGEMENT FEES" ON THE 990-PF RETURN ORIGINALLY FILED. THE ENTRIES WERE ACTUALLY FOR CHARITABLE PAYMENTS WHICH HAD BEEN THOUGHT TO BE "OUTSTANDING CHECKS" AS OF 06/30/13. THEY WERE ENTERED (CORRECTELY) AS CONTRIBUTIONS ON THE 990-PF RETURN FOR 2012. AS A RESULT, THE \$35,000 AMOUNT WAS DEDUCTED TWICE.

ON THE BALANCE SHEET SIDE, THE "CASH IN BANK", BEFORE ACCOUNTING FOR OUTSTANDING CHECKS, WAS \$77,725. THAT BALANCE WAS REDUCED TO \$33,725 BY "OUTSTANDING CHECKS" WHICH INCLUDED THE \$35,000 ALLUDED TO ABOVE. CONSEQUENTLY, THE REDUCED INCOME AMOUNT APPEARED TO "RECONCILE" WITH THE REDUCED CASH REPORTED – BOTH OF WHICH WERE INCORRECT.

THIS AMENDED RETURN IS THEREFORE ADJUSTED, INCREASING THE 2012 RETURN'S NET INCOME BY \$35,000 AND THE CASH BALANCE BY THE SAME AMOUNT.

THE RESULTANT \$700 EXCISE TAX LIABILITY ON PART VI, LINE 9, IS BEING PAID ELECTRONICALLY ON OR ABOUT THE TIME OF MAILING THIS RETURN. IT IS REQUESTED THAT ANY FOLLOW UP INTEREST OR PENALTY "LATE PAYMENT" ASSESSMENTS BE DIRECTED TO THE ADDRESS ON THIS RETURN, C/O TRUSTEE, SEAN W. THOMAS.
