THE PIPP PROGRAM (PERCENTAGE OF INCOME PAYMENT PLAN) CONTINUES TO INCREASE EACH YEAR TO ALLOW MORE HOUSEHOLDS TO BENEFIT FROM THIS AFFORDABLE

THE PROGRAM COVERS ROOFS, PLUMBING, WIRING, FLOORING AND WINDOWS.
