	Each year, following a specific formula, the Pine Rest Foundation awards grants to Pine Rest Christian Mental Health Services to fund various aspects of behavioral health care and counseling programs. An award of \$462,630 was made to provide funds for financial assistance for patients with the inability to pay for services. An additional \$430,520 was made available for education, prevention and support programs throughout the Hospital. Funding was provided to conduct research on outcomes of Electro Convulsive Therapy (ECT) and measure improvement in mental health and functioning after treatment and in turn improve practice at Pine Rest. Funding was provided to conduct quality research studies at Pine Rest, allowing staff to understand the current standards and best practice for protecting human subjects, while ensuring that all requirements are met, including approval from an Institutional Review Board, maintenance of documentation and ensuring that the research is conducted according to the approved protocol. Funding was provided for education and the implementation of treatment models for behavioral medicine within the outpatient network relating to psychiatric symptoms of chronic illnesses (such as diabetes, high blood pressure, and heart disease). Funding was provided to support accessible and flexible trainings specific to behavioral health care services, as well as the ability to develop individualized trainings specific to Community and Residential Services needs. Funding was also provided for a Model of Care Implementation within the Hospital. A number of research, development and training programs were also funded.
