Family Education
We provide Family to Family classes which is a 12 week program for family members designed by our national organization and designated as a Evidenced Based Practice. It is listed on the National Registry of Evidenced based Programs and Practices by the Substance Abuse and Mental Health Services Administration. Our expenses include direct expenses of \$361. We also have support from our Community Mental Health Clinton Eaton Ingham.
We provide NAMI Basics for families with school children affected by mental illness. This is an 8 week program and includes information of how to help a child in school and development of a 504 plan. We have direct expenses of \$662.
We have indirect costs of \$2010 which includes attendance at conferences, support to national and state organizations, telephone, web costs, and incidental costs.

4b (Code:) (Expenses \$ 3554 including grants of \$ 0) (Revenue \$ 0)

We provide support for persons with mental illness and families through support groups with direct cost of \$334. We also provide support through social activities such as movie, attending a statewide NAMIWalks, winter party, picnic, and others with a direct cost of \$720. We also provide support to a consumer organization with a grant of \$200. We have indirect costs of attending conferences, support to our national and state organizations for training, telephone, web costs, and incidental costs totaling \$2300.

4c (Code:) (Expenses \$ 2193 including grants of \$ 0) (Revenue \$ 0)

We provide education to the community via pamphlets, web, telephone calls, writing for newspapers, radio interviews, speaking for community groups and leaders. Our direct expenses include purchasing and printing of materials at a cost of \$389.
We had a booth at a Mental Health Conference at a cost of \$100. We have indirect expenses of \$1704 which included attending conferences, telephone, web, and support for our national and state organizations who provide us with information.
