The Foundation conducted a major campaign to raise matching funds for the renovation of the College's entire Health Professions Building. Contributions to the Foundation were transferred to Delta College to renovate the multi-level health wing including all of the training facilities, classrooms, offices and clinic areas. The Foundation's goal is to raise \$7 million of the \$20 million building project. This year, the Foundation transferred almost 4 million to the college for these renovations. The new facilities will benefit approximately 3,300 students enrolled in various health related fields.

Endowment fund contributions to the Foundation were invested in Delta College's Endowment Fund. Investment income from this fund financed approximately 260 scholarships and student awards this past year. This income also supports several college programs and projects such as Teaching Chairs, the Possible Dream Program and Professional Speaker presentations just to name a few. These educational opportunities benefit the entire Delta College community of approximately 18,900 students, faculty and staff as well as the surrounding communities.
