GROCERY PANTRY PROGRAM:

KLF IS THE LARGEST PROVIDER OF CHARITABLE FOOD ASSISTANCE IN KALAMAZOO COUNTY. THROUGH PARTNERSHIP WITH 25 FAITH AND COMMUNITY-BASED SITES, KLF DISTRIBUTES SAME-DAY GROCERY ASSISTANCE (4 DAYS OF NUTRITIONALLY BALANCED FOODS VIA A SHOPPING EXPERIENCE) TO ELIGIBLE INDIVIDUALS ACROSS THE COUNTY.

IN THE 2012/13 FISCAL YEAR, THE GPP DISTRIBUTED 1,666,181 LBS OF FOOD TO INDIVIDUALS AND FAMILIES ACROSS KALAMAZOO COUNTY. KLF PROVIDED 4-DAY FOOD ORDERS TO THE EQUIVALENT OF 126,603 INDIVIDUALS THROUGH THIS PROGRAM OVER THE COURSE OF THE YEAR. ELIGIBILITY FOR ASSISTANCE IS BASED ON SELF-DECLARATION OF NEED AND CAN BE ACCESSED ONCE WITHIN 30 DAYS.

KLF PROVIDES WEEKEND FOOD PACKS TO CHILDREN IN PARTNERSHIP WITH KALAMAZOO COMMUNITIES IN SCHOOLS (CIS). PARTICIPATING CHILDREN, ENROLLED WITH PARENTAL PERMISSION, RECEIVE SUPPLEMENTAL FOOD TO AUGMENT THEIR ACCESS TO FOOD ON WEEKENDS. THE PROGRAM OPERATES 32 WEEKS DURING THE SCHOOL YEAR AS WELL AS DURING THE 5 WEEK SUMMER SCHOOL PROGRAM. THERE IS ENOUGH FOOD IN THE PACK TO COVER APPROXIMATELY 2.5 MEALS AND SNACKS DURING WEEKEND HOURS WHEN OTHER FOOD OPTIONS MAY BE SCARCE. DURING FISCAL YEAR 2012/13 THE WEEKEND FOOD PACK PROGRAM DISTRIBUTED 134,035 POUNDS OF FOOD THROUGH THE 26,807 FOOD PACKS PROVIDED TO NEARLY 1,000 CHILDREN A WEEK.
