THE FOUNDATION ASSUMED THE ROLE OF ADMINISTERING CONTRIBUTED FUNDS FOR SUPPORT OF MILWAUKEE PUBLIC TELEVISION, WHICH WERE PREVIOUSLY HANDLED BY A SEPARATE 501(C)3 ORGANIZATION. MILWAUKEE PUBLIC TELEVISION IS OWNED AND OPERATED BY THE MILWAUKEE AREA TECHNICAL COLLEGE. THE FOUNDATION ADMINISTERED \$5,518,133 IN CONTRIBUTIONS FOR MILWAUKEE PUBLIC TELEVISION AND DISBURSED \$5,461,040 IN GRANTS IN ITS FIRST FULL YEAR IN THIS ROLE. INCLUDED IN THE GRANTS WAS \$233,000 IN DISBURSEMENTS FROM A QUASI-ENDOWMENT MANAGED BY THE FOUNDATION FOR MPTV'S GENERAL OPERATIONS.
