These Amended and Restated Articles of Incorporation of REGISTRAR ACCREDITATION BOARD, INC., a nonstock corporation organized and existing under the laws of the State of Wisconsin (the "Corporation"), were duly adopted pursuant to the authority and provisions of Chapter 181 of the Wisconsin Statutes and supersede and take the place of the Corporation's existing Articles of Incorporation and any amendments thereto.

ARTICLE I

The name of the Corporation is RABQSA International, Inc.

ARTICLE II

The period of existence of the Corporation shall be perpetual.

ARTICLE III

The Corporation is organized pursuant to section 501(c)(6) of the Internal Revenue Code of 1986, as amended, or any successor statute thereto (the "Code") for the following specific purposes:

1. To promote the best practices in the fields and professions relating to the certification of persons.
2. To certify persons and training organizations in all fields that require certification in order to perform competently and professionally.
3. To promote the professional development of persons and organizations that are served by the Corporation.

4. To exercise any, all and every power that a nonprofit corporation, organized under the Wisconsin nonstock corporation law, can be authorized to exercise, but not for any purpose which contravenes Code section 501(c)(6).

ARTICLE IV

Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any activities not permitted by a Corporation exempt from federal income taxes under section 501(c)(6) of the Code. No part of the assets, income or net earnings of the Corporation shall be distributable to, or inure to the benefit of, its members, directors, officers or any private individual, except that the Corporation shall be authorized to pay reasonable compensation for necessary services actually rendered to it and to make payments and distributions for the purposes of the organization. No dividends or pecuniary profits or liquidation dividends shall be declared or paid. Supplementary to the purposes of this organization, the Corporation may engage or participate in any activity, business or enterprise to procure funds for the purposes of the Corporation, but only, however, to the extent that such activity, business or enterprise will not jeopardize the tax-exempt status of the Corporation.

ARTICLE V

The Corporation shall have members. The sole member shall be the American Society for Quality, Inc., a New York nonprofit corporation ("ASQ"). The By-Laws of the Corporation shall designate the rights, including voting rights, of members.

ARTICLE VI

The affairs of the Corporation shall be managed by a Board of Directors as set forth in the By-Laws of the Corporation. Any action required or permitted to be taken at a meeting of the Board of Directors may be taken without a meeting if a consent in writing setting forth the

action is signed by at least two-thirds of the directors then in office. The interest of any director, officer or member in this Corporation shall not be assignable inter vivos, nor shall it pass to any personal representative, heir or devisee.

ARTICLE VII

Nothing contained in these Articles shall be construed to prevent a distribution of the properties of the Corporation otherwise properly made in accordance with the provisions of these Articles and the purposes herein stated, solely by reason of the fact that one or more of the directors or officers of the Corporation may be connected or associated with the distributee as member, trustee, director, officer or in any other capacity.

ARTICLE X

AGREEMENT AND PLAN OF MERGER OF
INARTE, INC.
WITH AND INTO
RABQSA INTERNATIONAL, INC.

THIS AGREEMENT AND PLAN OF MERGER, dated this 11th day of May, 2012 is made and entered into by and between INARTE, INC., a Massachusetts nonprofit corporation ("INARTE"), and RABQSA INTERNATIONAL, INC., a Wisconsin nonstock corporation ("RABQSA"), jointly referred to hereinafter as the "Merging Corporations."

RECITALS

- A. RABQSA is the sole voting member of INARTE.
- B. The Board of Directors of RABQSA and INARTE deem it to be in the best interest of the Merging Corporations that INARTE merge with and into RABQSA (the "Merger").
- C. The Board of Directors and the sole voting member of INARTE, and the Board of Directors of RABQSA, have approved this Agreement and Plan of Merger.

AGREEMENTS

In consideration of the recitals and mutual agreements which follow, the parties agree as follows:

ARTICLE I
PLAN OF MERGER

1. The Merger. At the "Effective Time" (as defined below) of the Merger, INARTE will be merged with and into RABQSA in accordance with the Massachusetts Statutes and the Wisconsin Statutes. After the Merger, RABQSA will be the surviving corporation and the separate existence and identity of INARTE shall cease to exist.

2. Effects of the Merger. At the Effective Time of the Merger:

(a) RABQSA shall possess all the rights, privileges, immunities and franchises, of a public nature as well as of a private nature, of each of the Merging Corporations;

(b) All property, real, personal and mixed and all debts due on whatever account, and all choses in action, and every interest, of or belonging to or due to each of the Merging Corporations, shall be taken and deemed to be transferred to and vested in RABQSA without further act or deed;

(c) Title to any real estate, or any interest therein, vested in each of the Merging Corporations shall not revert or be in any way impaired by reason of the Merger;

(f) Neither the rights of creditors nor any liens upon the property of the Merging Corporations shall be impaired by the Merger.

3. Articles of Incorporation and By-Laws. The Articles of Incorporation and By-Laws of RABQSA as they exist prior to the Merger shall remain in effect as the Articles of Incorporation and By-Laws of RABQSA after the Merger and shall not be affected by the Merger.

4. Purpose. The purpose of RABQSA following the Merger shall be:

(a) To promote the best practices in the fields and professions relating to the certification of persons;

(b) To certify persons and training organizations in all fields that require certification in order to perform competently and professionally;

(c) To promote the professional development of persons and organizations that are served by the Corporation; and

(d) To exercise any, all and every power that a nonprofit corporation, organized under the Wisconsin nonstock corporation law, can be authorized to exercise, but not for any purpose which contravenes Code section 501(c)(6).

5. Outstanding Membership Interest. At the Effective Time of the Merger, the outstanding membership interest of INARTE shall, by virtue of the Merger and without any additional action, be canceled and extinguished without any conversion thereof and no payment shall be made with respect thereto. The outstanding membership interests of RABQSA shall not be affected by the Merger.


