DAY SCHOOL - THE PRIMARY GOAL FOR STUDENTS AT GROVES IS TO STRENGTHEN THEIR BASIC ACADEMIC SKILLS. CURRICULUM AND INSTRUCTION FOR STUDENTS IN GRADES 1-12, SUMMER SCHOOL, AND POST-SECONDARY EDUCATION ARE BASED ON THE BELIEF THAT STUDENTS WITH LEARNING DISABILITIES LEARN BEST WHEN INSTRUCTION ADDRESSES INDIVIDUAL STRENGTHS AND WEAKNESSES. TO FACILITATE THIS BELIEF, EACH STUDENT'S COGNITIVE, ACADEMIC, AND SOCIAL STRENGTHS AND WEAKNESSES ARE IDENTIFIED, AND AN INDIVIDUAL EDUCATIONAL PROGRAM IS DESIGNED. STUDENTS ARE GROUPED INTO SMALL CLASSES, METHODS AND MATERIALS ARE GEARED TOWARD INDIVIDUAL NEEDS, AND STUDENTS ARE ACTIVELY ENGAGED IN LEARNING THROUGH MULTI-SENSORY INSTRUCTION. TEACHERS GUIDE STUDENTS' LEARNING BY COMBINING PROFESSIONAL EXPERTISE WITH COMPASSION, RECOGNIZING THAT THE FOUNDATION OF LEARNING IS THE
