 In fiscal year 2013, Plains Art Museum served 58,000 visitors of all ages through high quality art exhibitions, educational programs, live music, and outreach activities. The Katherine Kilbourne Bugum Center for Creativity opened and served 5,500 regional students. The museum offers six to eight major exhibitions annually with an equal number of smaller exhibitions. The museum's permanent collection of 3,800 objects is also used for special exhibitions and research, occasionally shown in national and international venues. Exhibitions focus on artists in the community and region.
