Marshall Area Christian School served 113 students in grades preschool through 8th grade. There were 175 contact days of school for grades kindergarten through 8th grade held during the school year. As a part of the school day education, MACS provided students opportunities to minister and serve in the community. Fine Arts February which included extra learning opportunities in a variety of fine arts areas, a dinner theater written, performed and produced by the 7th and 8th grade classes, a spring musical performed by the kindergarten through 6th grade classes; and multiple learning opportunities through multiple field trip events. MACS also provided after-school learning opportunities through sports, including flag football, volleyball, basketball & cheerleading. Additional after-school educational programs included science club, knowledge bowl team and speech team activities. A lunch program was provided to students on three days per week with a focus on nutrition through organic foods and local produce, meat and dairy products purchased directly from farmers as much as possible.

The chairman's wife is employed as the preschool teacher for the school and another board member's wife works in the school's lunch program. In addition, a board member sells farm produce to the school's lunch program.

The school board has given each school board member the responsibility of an area of service (fund raising, building, spiritual development, etc.) They are given authority to spend funds within the area of responsibility within the school board approved budget. Actions and decisions for these areas are documented for the purposes of planning and organization. A central file of documentation of each committees' meetings and/or actions is not maintained by the MACS school office. Individual board members maintain their own information and documentation for their area of responsibility.

For example, the wife of our current school board chairman is a part-time teacher for MACS. When issues arise in relation to her pay (i.e. pay rates), he does not vote or take part in that discussion. Monitoring and compliance is handled appropriately for each occurrence within the school board meetings.
