	The Arts Activities Support program offers grants of up to \$10,000 in project support for groups wishing to offer quality arts activities in any discipline to communities within the seven-county metro area. Grant requests may include costs for artists and other personnel, postage, supplies, equipment, printing, travel and other expenses necessary to carry out the project. In FY2013, MRAC received 226 applications requesting \$2,096,701, and awarded 125 grants totaling \$1,199,048 in this program. The Community Arts grant program provides grants of up to \$5,000 in project support for metro groups wishing to offer quality arts activities in any discipline to communities within the seven-county metropolitan area. The program utilizes a block grant system to distribute funds. Each of the counties in MRAC's service area Anoka, Carver, Dakota, Hennepin, Ramsey, Scott and Washington receives a block of funds designated for arts activities occurring within that county. Community Arts is intended for community based and volunteer groups, smaller, established arts groups, and newly formed groups or first-time initiatives. Grant requests may include costs for artists and other personnel, postage, supplies, equipment, printing, travel and other expenses necessary to carry out the project. In FY2013, MRAC received 175 applications requesting \$830,828, and awarded 127 grants totaling \$605,412 in this program. The Arts Learning program provides grants of up to \$10,000 for high-quality, age-appropriate arts education for Minnesotans of all ages to develop knowledge, skills, and understanding of the arts. MRAC's goals for the Arts Learning Program are to cultivate creativity and deepen knowledge of and/or through the arts for children, youth and adults by engaging people in extended arts experiences and activities with clearly articulated learning objectives. In FY2013, MRAC received 124 applications requesting \$1,099,380, and awarded 45 grants totaling \$415,874 in this program. The Creative Intersections program is designed to support innovative partnerships that integrate arts and culture into plans for community development and enrichment. The Creative Intersections grant program provides up to \$15,000 for projects that will build bridges among community sectors and that have the benefit of building momentum toward strengthening the community as a whole through a quality arts development project. In FY2013, MRAC received 26 applications requesting \$355,537, and awarded 9 grants totaling \$118,422 in this program. The Organizational Development program offers grants of up to \$10,000 for projects designed to strengthen the management or administration of nonprofit arts groups. Such projects must 1) advance the mission of the group and 2) have the potential for significant or long-term impact. In FY2013, MRAC received 50 applications requesting \$485,114, and awarded 25 grants totaling \$228,612 in this program. The Capital grant program provides funds of up to \$10,000 to purchase equipment and related supplies and services, or to make capital improvements. Such activities must 1) advance the mission of the group and 2) have the potential for significant or long-term impact. In FY2013, MRAC received 38 applications requesting \$287,888, and awarded 20 grants totaling \$149,196 in this program. The ADA Access Improvement Fund is operated in partnership with VSA Minnesota, a nonprofit organization specializing in arts programs and services for people with disabilities. The program provides grants of up to \$15,000 for arts organizations to increase accessibility to consumers and participants in their activities. In FY2013, MRAC paid VSA Minnesota a grant of \$220,000 for administration and grants for this program. In addition, MRAC awarded one grant of \$600 through its Emergency Accessibility program directly to one organization to meet unforeseen audience accessibility needs. The Management Consulting Fund program offers grants of up to \$1,500 to provide consultants for groups to complete small projects to strengthen the management or administration of the group. Such management consulting projects must 1) strengthen the management or administration of nonprofit arts groups, 2) advance the mission of the group, and 3) have the potential for significant or long-term impact. The Management Training Fund program offers grants of up to \$600 to provide training funds for the staff and volunteers of nonprofit arts groups to attend management workshops, seminars or conferences. In FY2013, MRAC received 96 applications requesting \$64,066 and awarded 81 grants totaling \$41,617 in these two programs. The Next Step Fund is MRAC's grant program for individual artists, providing grants up to \$5,000 to professional artists in any discipline for the purpose of career development and artistic achievement. The Next Step Fund is funded entirely by the McKnight Foundation. In FY2013, MRAC received 376 applications requesting \$1,692,000 and awarded 38 grants totaling \$180,225 in this program.
