MADE THE DECISION TO LAUNCH A CAPITAL CAMPAIGN TO BUILD AVERA CANCER INSTITUTE MARSHALL THIS NEW CANCER CENTER WILL PROVIDE RADIATION THERAPY FOR THE FIRST TIME IN THE AVERA MARSHALL SERVICE AREA ONCE IT IS COMPLETED PHILANTHROPIC DOLLARS, IN CONJUNCTION WITH THE \$7 MILLION SET ASIDE FROM THE SALE OF THE MEDICAL CENTER FROM THE CITY OF MARSHALL TO AVERA HEALTH, WILL PROVIDE ENOUGH SUPPORT TO FUNDRAISING, EVENTS WERE HELD, INCLUDING A TRUCK PROVIDED BY LOCKWOOD MOTORS OF MARSHALL, WHICH WAS DRIVEN AT AREA PARADES FUNDRAISING AND AWARENESS ALSO TOOK PLACE AT THE LYON COUNTY PRCA RODEO FOR
