Fellowships. With the support of the McKnight and Jerome Foundations, the Playwrights Center provided fellowships to 14 playwrights and theater artists last season. These include the four Many Voices fellowships for beginning and emerging playwrights of color - one of the only programs of its kind in the country - that focus on providing educational support and career development, four Jerome fellowships that provide support to emerging national playwrights, three McKnight Theater Artist fellowships that recognize the work of Minnesota artists, two McKnight Advancement Grants for established Minnesota playwrights, and one McKnight National Residency and Commission that supports a nationally renowned playwright and the development of a new play. These fellowships give artists time and opportunity to focus on creating. The Playwrights Center functions as a home to these artists during their fellowship year and all recipients are offered development funds to work in the Center's Ruth Easton Lab.

The Ruth Easton Lab. The Ruth Easton Lab is one of the most prolific laboratories for new play development in the country. The Lab brings Core Writers - a group of 25-30 established, mid-career, and emerging playwrights from across the country - and their collaborators (directors, dramaturges, designers and actors) together in Minneapolis to develop their work in 10-30 hour workshops. In 2012-13, the Center hosted a total of 44 play development workshops in the Lab, 18 of which were provided for Core Writers. Some of those plays were chosen to be presented in the Ruth Easton New Play Series or PlayLabs, the Center's season of public readings. In 2012-13 the Playwrights' Center produced five free staged readings of Core Writers and fellows plays in the New Play Series, and another three in PlayLabs. Local and national theater partners also utilize the Lab to develop work for their stages.

Membership. The Playwrights Center is one of the largest open-membership organizations for playwrights in the country. Individual memberships (\$50/year) provide career development, networking, and access to resources. In FY12, the Center's 1,176 members took advantage of our online opportunities listings, and our staged reading, dramaturgy, and class programs. In addition to general membership, the Playwrights Center also offers New Plays on Campus, an institutional membership program that works directly with colleges and universities to offer students the opportunity to develop their plays and to provide residencies and productions for playwrights. There were 42 NPOC schools in the 2012-13 season.
