The funds and their earnings are to be used by the determination of a committee to fund grants to the Johnston Community School and scholarships to students each year that are to be paid directly to the College they are attending. The students are chosen on a non-discriminatory basis from graduating seniors from the Johnston Community School District who plan to go on to a 4 year college. The quasi-endowment funds were invested in the hope that the earnings would fund the bulk of the grants given out each year so that the legacy of the scholarships and grants could continue. Since there were enough funds from other annual contributions, annual fund raisers and assets outside of the quasi-endowment funds to fund the grants, the quasi-endowment fund investment has been allowed to grow. This decision was implemented in recent years when market losses have negatively affected the fund's balance. Spending from the endowment is determined by committee each year, with grant spending not to exceed 5%.
