The committee makes a motion to approve the 990 as completed or requires that the report be amended. A record of the committee's actions is recorded and maintained with the corporate records. Finance members receive a copy and it is made available to all other board members.

Part VI Section B 12c - Lafayette House has a written Conflict of Interest Policy. The Board of Directors are required to review the policy, sign that they agree to comply and submit in writing potential conflicts, at least annually. As part of our written corporate compliance plan, the corporate compliance officer is responsible for monitoring risk areas and to ensure ongoing conformance with this policy.

Part VI Section 15b - Annually, the President of the Board of Directors appoints a Personnel Committee to conduct an evaluation of the Executive Director's performance for the past year. Following this review the committee reviews the evaluation results with the Full Board of Directors and submits a recommendation for the Executive Directors compensation for the coming year. Compensations for other key employees is established by the Executive Director and submitted to the Full Board of Directors for final review and approval.

Part VI Section C 19 - Lafayette House makes all governing documents, conflict of interest policy and financial statements available to anyone by request. The Executive Director or designee will assist any person requesting access to these documents by appointment. In addition, certain documents are regularly submitted to outside monitoring or oversight organizations including: minutes from the Board of Director's meetings and monthly operating income statements are mailed monthly to our regional United Way Office; governing documents are reviewed semi-annually by monitors from the Missouri Department of Mental Health in conjunction with their certification review; policies including conflict of interest are distributed to all employees at their initial orientation session. Annual independent audits and financial reports are filed with approximately 18 external funding entities (local, state, and national).
