Junior Achievement of Middle America, Inc. reached 20,004 students in Kansas and Missouri through 905 classes taught by 751 volunteers throughout the 2012-13 school year. Through these classes, students received 116,897 contact hours of instruction that meets the common core educational standards recognized in Kansas and Missouri. The number of students reached reflects a 4.15% increase over the previous fiscal year. An additional 50 volunteers helped raise money for Junior Achievement through the Bowl-a-Thon, the Greater Kansas City Business Hall of Fame, and Call for Kids campaign. Local businesses also provided in-kind services totaling over \$23,000.
