Circle of Nations is a residential school serving American Indian youth in grades 4 through 8. In 2013 there were 135 students who attended the school. The purpose of the Circle of Nations residential educational program is to prepare students to learn, and to foster a healthy development of the whole child in a Native American cultural environment. The school's mission and purposes are reflected in the vision statement "Circle of Nations is the spirit of youth empowered." Circle of Nations School was awarded the Carol M. White Physical Education Program (PEP) August of 2012 and the Otto Bremer Hero's-in-Residence grant.
