Each participating educator then designed and created an after-school program and other innovations that were designed to enrich the larger education technology community at their school.**

**The Digital Harbor Foundation Tech Center is located in the former South Baltimore Rec Center. Programs created by DHF and run at the Tech Center include a series of summer technology camps, after-school programs teaching web or mobile application development, digital fabrication (including 3D printing), and other technology related skills.**
