Safe Harbor staff can be contacted via telephone 24 hours a day, 7 days a week, 365 days a year The Organization shelters victims and children of domestic violence for a temporary period of time while they are looking for a new, safe place to live The Organization also provides advocacy services for victims of domestic violence, sexual assault, bullying, and stalking In FY2013, Safe Harbor assisted 338 women, children and men that were victims of domestic violence Safe Harbor also assisted 57 stalking victims, 10 sexual abuse victims, 3 adolescent sexual abuse victims, 15 child abuse victims, 52 domestic violence protection orders, and 21 stalking protection orders The Organization sheltered 51 women and 51 children, providing 3,050 bed nights and 9,150 meals
