Children and Youth-CRYP offers a variety of interesting, innovative
educational and recreational youth programs and services for the
young people of the Cheyenne River Reservation. The following programs
and services will be broken down into programs for Children ages 4-12 years
and programs for teenagers 13-18 years.

Programs for Youth 4-12: The Main Youth Center is a drop-in youth
facility that operates on average five days per week, from 4 p.m.
to 8 p.m. during the school year and from 1 p.m. to 8 p.m. during
the summer. It was open for 219 days with 4,328 youth contacts.

English is Leading Lady) 2 acre organic garden begins in the spring
and runs through late fall. Young people are engaged in every step of the
growing process-preparation, planting, maintenance and harvesting
the produce. Garden Club is offered every week, for 4-12 year old
children, during the growing season and involves direct work in the garden,
followed by guided journaling with the help of a volunteer.
Journaling helps participants process their experiences and understanding of
how the garden has developed over time. Working in the garden also
encourages healthy nutrition and responsibility in youth participants.

On average CRYP has about 20 youths attending daily. This facility is where CRYP most often makes their first contact with Cheyenne River's youth. For this reason, CRYP designed the Main's programs to develop interests and lay the ground work of basic skills which can be built upon later when the child transitions into the teen center.

Teen programs -- 13-18 years. The Teen Center was open 236 days with 8,334 youth contacts; with an average of 35 youth per day. This activity delivers programming in education, health, wellness, arts, culture, leadership and more.

families - an average of 450 people served each month. The program also served 225 families not enrolled in the program through emergency services. CRYP provided new winter coats for 436 people and 300 boots for adults and children living on the Cheyenne River Reservation as well as other resources to help families. Also personal hygiene items, feminine products, deodorant, brushes, combs, and soap were given to members. School supplies were distributed to approximately 461 children through a distribution but continued to be available throughout the year. And the Christmas Toy Drive provided toys for 1,200 children. Our facility is open 253 days a year, and served a total of 11,357 individuals during the year.

Approximately 50 children participated in this program. The 2012 garden season was a good crop considering the drought conditions and early departure of CRYP's gardener who had worked for CRYP for 10 years. The garden produced raspberries, strawberries, jalapenos, four varieties of tomatoes, cauliflower, carrots, sweet potatoes, cucumbers, eggplant, squash (3 varieties), rhubarb, asparagus, green peppers, and corn. Native garden techniques (3 Sisters garden) is employed to produce corn, beans and squash and teach the children about tradition and culture. The produce harvested from the garden is used to provide food for the two youth centers and if sufficient excess exists it is shared with other organizations such as the Elderly Manor and shelters. Food produced from the garden is also sold at the youth project Farmer's Market which is designed to teach children about entrepreneurship, social enterprise, etc. Produce is also preserved by canning and stored for future use or sold at Farmer's Market or in the Teen Center Gift Shop. Revenues generated through farmers market and gift shop sales are reinvested in the garden project.
