GRANTEEES RANGED IN AGE FROM 12 YEARS OLD TO 88 YEARS OLD. GRANT AMOUNTS RANGED FROM \$100 TO \$1,000. WE FUNDED PROJECTS SUCH AS COMMUNITY GARDENS THAT SERVE LOW-INCOME POPULATIONS, ANIMAL RIGHTS EFFORTS THAT ENCOURAGE HUMANE TREATMENT OF ANIMALS AS WELL THE PROMOTION OF VEGANISM, ECONOMIC DEVELOPMENT PROGRAMS, ENVIRONMENTAL SUSTAINABILITY, AND CONSERVATION. THE POLLINATION PROJECT AND OUR GRANTEEES WERE FEATURED IN OVER 100 NEWS STORIES IN MEDIA INCLUDING PARADE MAGAZINE, WOMAN'S DAY, FOX MORNING SHOW, CHRONICLE OF PHILANTHROPY, AND MANY LOCAL NEWSPAPERS AND TV NEWS BROADCASTS NATIONWIDE.
