**28** AMCHA Initiative investigated concerns from students at the University of California campuses at Los Angeles, Davis, Berkeley, Riverside, and San Diego. The students reported experiences on campus that they perceived to be anti-Semitic harassment and hostility. They included physical threats and verbal harassment as well as hecklers disrupting Jewish student events, as well as faculty using university resources to promote the boycott of Israeli academics, institutions, and citizens. AMCHA Initiative investigated and affirmed the student concerns and publicized the incidents to members of the Jewish community as well as to the respective administrations of the UC campuses.
