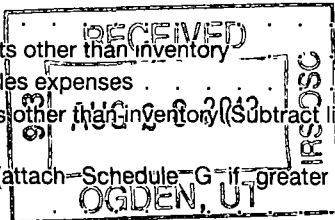

The organization also mobilizes and equips volunteers and organizes efforts around community-focused initiatives including but not limited to restorative home repair, disaster relief and fire recovery, and meeting the needs of underserved families during the holiday season.

SERVE 6.8 will take over operation of the Murphy Center on July 1st, 2013. We are currently involved in staff hiring, facility operation management, fundraising and program development for that deadline.
