IT WAS NOT AS A RESULT OF WILLFULL NEGLECT ON BEHALF OF THE BOARD, BUT RATHER AN INADVERTANT OVERSIGHT AND LACK OF COMMUNICATION THAT RESULTED IN THE FAILURE TO FILE.
