The parent supplies their income level and number of dependents on the application. The student enrollment is then verified with the administration of the school by our organization. An application is only valid for one school year, and the parent must re-apply each school year. The Yuma's Education scholarship Fund Board reviews the application and awards scholarships based on financial need. Upon Board approval the scholarships are issued to the qualified private schools in Arizona. The school is informed by letter that they may not receive an amount per student (from all tuition organizations) in excess of the total tuition due for each school year. In the event an excess amount is received by the school, then they must return the funds to the school tuition organization. The application is available on our website.
