VENDING MACHINES AND ATMS ARE PROVIDED FOR THE CONVENIENCE OF STUDENTS, FACULTY, AND ADMINISTRATIVE STAFF. RENTAL INCOME IS FOR KITCHEN EQUIPMENT AND A SUPPLY ROOM USED TO OPERATE A FOOD COURT WHICH SERVES BREAKFAST AND LUNCH TO STUDENTS, FACULTY, AND ADMINISTRATIVE STAFF. ON SEPTEMBER 18, 2006, THE ORGANIZATION SOLD MOST OF ITS INVENTORY AND EQUIPMENT TO MATTHEWS MEDICAL AND SCIENTIFIC BOOKS, INC. THE ORGANIZATION GRANTED MATTHEWS THE RIGHT TO OPERATE BOOKSTORES ON THE CAMPUSES OF THE UNIVERSITY OF KANSAS MEDICAL CENTER FOR A FIVE YEAR PERIOD BEGINNING SEPTEMBER 18, 2006 WITH A THREE YEAR RENEWAL OPTION. MATTHEWS WILL PAY THE ORGANIZATION A MINIMUM ANNUAL COMMISSION OF \$100,000 PAYABLE IN QUARTERLY INSTALLMENTS. ADDITIONAL COMMISSIONS WILL COMMENCE IF SALES EXCEED \$1,642,857. MATTHEWS REIMBURSES THE UNIVERSITY OF KANSAS FOR ACTUAL UTILITY COSTS. THIS AGREEMENT ENDED IN SEPTEMBER 2011. SUBSEQUENTLY, THE ORGANIZATION SIGNED A THIRD-PARTY CONTRACT WITH A RELATED PARTY, THE UNIVERSITY OF KANSAS MEMORIAL CORPORATION (KUMC), TO OPERATE THE BOOKSTORES ON THE CAMPUSES OF THE UNIVERSITY OF KANSAS MEDICAL CENTER. THE AGREEMENT IS FOR A FIVE-YEAR PERIOD BEGINNING IN SEPTEMBER 2011, WITH FIVE ADDITIONAL ONE-YEAR RENEWAL OPTIONS. EITHER PARTY MAY TERMINATE THE CONTRACT BY PROVIDING WRITTEN NOTICE TO THE OTHER PARTY SIX MONTHS PRIOR TO THE SEPTEMBER ANNUAL START TERM. KUMC PAYS THE ORGANIZATION A MINIMUM ANNUAL COMMISSION OF \$40,000, PAYABLE IN MONTHLY INSTALLMENTS. ADDITIONAL COMMISSIONS WILL COMMENCE IF SALES EXCEED \$1,250,000.
