Mid-America Nazarene University (MNU), a liberal arts university sponsored by the Church of the Nazarene, provides a nurturing environment where students gain broad-based knowledge and skills that will serve them professionally and personally throughout their lives. The MNU experience is one that provides students with Christ-centered educational opportunities that teach real-world learning through pioneering programs that prepare them to be servant leaders and encourages them to discover their purpose, values, and direction. Founded in 1966, Mid-America is located in Olathe, Kansas, a suburban community just 20 miles south of Kansas City. Total enrollment for fall, 2012, was 1,978 students. The four largest undergraduate programs are Nursing - 350, Applied Organizational Leadership, formerly Management and Human Relations - 291, Elementary Education - 79, and Business Administration - 53. The University offers undergraduate academic majors in 36 areas, degree-completion programs in business, nursing, and public administration, and graduate degrees in education, nursing, business, and counseling. Students may apply to study abroad through MNU Europe, located in Busingen, Germany. A variety of special interest clubs, traveling music groups, band, concert choir, student government, and outreach groups are available. The University provides intercollegiate competition in football, volleyball, softball, baseball, men's and women's basketball and soccer. Chapel services provide an emphasis on spiritual formation, and revivals foster spiritual vitality on campus.
