


- More than \$1,254,000 for the cardiac initiative. This money has helped fund a state-of-the-art catheterization lab and a Cardiology (PACS) Picture Archiving Computer System, purchase a 64-slice CT scanner, recruit two interventional cardiologists, and establish The Heart Institute at Mercy Regional.
