AFTER DISCOVERING THE INADVERTENT OVERSIGHT, THE ORGANIZATION MOVED QUICKLY TO HAVE THE FORM 990 PREPARED AND FILED IMMEDIATELY AFTER THE AUDITED FINANCIAL STATEMENTS WERE COMPLETED AND BEFORE BEING NOTIFIED BY THE IRS THAT IT WAS LATE, THEREBY DEMONSTRATING THAT IT ACTED RESPONSIBLY AND IN GOOD FAITH AND ITS OMISSION WAS NOT DUE TO WILLFUL NEGLECT. AS MENTIONED ABOVE, THE LATE FILING WAS CAUSED BY THE CONFUSION OF THE SELECTION OF A NEW OUTSIDE ACCOUNTANT AND WAS AN ADMINISTRATIVE OVERSIGHT. THIS WAS THE FIRST TIME THE ORGANIZATION WAS LATE IN FILING OF THEIR FORM 990 AND THE ORGANIZATION HAS TAKEN THE NECESSARY STEPS TO ENSURE THAT THE LATE FILING WILL NOT HAPPEN AGAIN. IN ADDITION, THE NEW OUTSIDE ACCOUNTING FIRM HAS ALSO TAKEN STEPS TO ENSURE THAT THE ORGANIZATION WILL FILE THEIR FORM 990 ON A TIMELY BASIS. WE RESPECTFULLY REQUEST THAT YOU ACCEPT THIS STATEMENT OF REASONABLE CAUSE AND REFRAIN FROM ASSESSING THE LATE FILING PENALTIES AGAINST THE ORGANIZATION AS IT WOULD BE AGAINST EQUITY AND GOOD CONSCIENCE TO IMPOSE SUCH A PENALTY ON THIS SMALL TAX-EXEMPT ORGANIZATION. THE LATE FILING WAS NOT AN ACT OF DELIBERATE LATE FILING BUT WAS AN ADMINISTRATIVE OVERSIGHT WHICH WILL NOT HAPPEN AGAIN. THIS STATEMENT OF REASONABLE CAUSE IS PART OF FORM 990 AND IS SUPPORTED BY THE SIGNATURE UNDER PENALTIES OF PERJURY PROVIDED ON SAID RETURN.
