To provide gifts and other sundries as part of providing assistance to the hospital patients and their families during the 365 days ended June 30, 2013. The total number of patients served is not known.

Line c

Operation of the hospital gift shop to promote the general welfare of the hospital patients and to assist in the funding of scholarship grants for deserving local students.

Line d

Providing charitable contributions to various IRS Code 501c(3) organizations located in the surrounding community.

Form 990, Schedule A, Part III, Line 3a, Explanation of how the individuals receiving scholarships qualify to receive payments

A scholarship committee reviews applications submitted by El Paso area students pursuing a degree in a medical related field and then submits a list of worthy students to the Board of Directors of the Association for scholarship consideration. The Board then approves scholarship recipients based on academic performance and financial need.
