In order to further Saint Agnes Healthcare's mission of providing quality healthcare and serving the poor, the Saint Agnes Foundation is developing the philanthropic resources needed to help fund and support the Campus Revitalization Project for Saint Agnes Healthcare, which includes constructing a new patient tower, redevelopment of the existing patient tower, the expansion and redesign of the Saint Agnes Cancer Center.

The Saint Agnes Foundation also provided other grants to Saint Agnes Healthcare. During the fiscal year ended June 30, 2013, the Saint Agnes Foundation received a \$244,455 grant from the AstraZeneca Healthcare Foundation and \$100,000 from Ascension Health to launch the Heart-to-Heart Program to identify and assess underserved, low-income African American women at high risk for cardiovascular disease and provide community-based intervention program. The Saint Agnes Foundation also received a \$90,000 grant from the Stulman Foundation to launch a Pre-Diabetes Program to educate and prevent advanced diabetes. The Saint Agnes Foundation used the proceeds from the annual Gala to provide \$226,770 of support towards the community development project involving the former

The Respect fund helps fund the costs of continuing education for the staff of Saint Agnes Healthcare. The Oncology Fund have helped continue outreach, education and support to patients with cancer and their families that are being cared for at Saint Agnes Healthcare. The Oncology fund also supported Cancer Survivors Day, which celebrates the successes of those that have survived cancer and provides additional

Saint Agnes Foundation also provided funding to other organizations, such as My Brother's Keeper, a faith based soup kitchen that provides both nutritional and spiritual nourishment and social services in an effort to break the cycle of poverty and addiction. Furthermore, Saint Agnes Foundation partnered with the Associated Italian American Charities to help fund education costs for nursing students.
