Baltimore County Public Schools Education Foundation, Inc., a Maryland not-for-profit corporation (the "Corporation"), hereby certifies to the Maryland State Department of Assessments and Taxation that:

FIRST: The Corporation's Articles of Incorporation, which were originally approved for record on October 26, 1992 (the "Articles") are hereby amended by deleting ARTICLE FIRST in its entirety, and substituting the following in lieu thereof:

FIRST: The name of the Corporation (which is hereinafter called the "Corporation") is: The Education Foundation of Baltimore County Public Schools, Inc.

SECOND: This amendment of the Corporation's Articles of Incorporation was duly advised and approved by the Board of Directors of the Corporation at a meeting held on March 13, 2013 in a manner and by the vote required by law and the Corporation's Articles of Incorporation.

THIRD: This amendment of the Corporation's Articles of Incorporation is limited to a change expressly authorized by Section 2-605 of the Maryland General Corporation Law to be made without action by the Members.

FOURTH: Each of the undersigned officers of the Corporation acknowledges, under penalties for perjury, that these Articles of Amendment are the corporate act of the Corporation and that the matters and facts set forth herein are true in all material respects, to the best of his or her knowledge and belief.
