POLICY & ADVOCACY: WHILE THE CIVICUS POLICY & ADVOCACY UNIT CONDUCTS ALMOST NO LEGISLATIVE LOBBYING, IT DOES TAKE UP ADVOCACY POSITIONS WITH THE EXECUTIVES OF NATIONAL GOVERNMENTS AND INTERNATIONAL ORGANIZATIONS ON THE BASIS OF OUR VALUES AND OBJECTIVES. CIVICUS WORKS TO EDUCATE CIVIL SOCIETY ORGANIZATIONS AND CITIZENS ON ISSUES DEALING WITH FREEDOMS OF ASSEMBLY, ASSOCIATION OR EXPRESSION SO THAT THEY ARE BETTER ABLE TO ENGAGE IN THE DECISIONS AFFECTING THEIR LIVES.
