Bright Prospect recruits students from the seven high schools it serves at the end of ninth
grade, guiding them toward college readiness and through the application process.
Bright Prospect continues to track and mentor students throughout their college years
until they reach graduation. During FY 2013, Bright Prospect served 1021 high school
students and 440 college students. 31% of Bright Prospect's college students attend
UC's, 24% Cal States, 28% private college, and 17% start at community college with the
goal of transferring. Bright Prospect has an overall persistence rate (year-to-year
re-enrollment) of 92% and an overall graduation rate of 91%. Bright Prospect's
signature strategy for college retention is called the Crews System, whereby
students attending the same college are organized into peer-support teams with
trained peer leaders, and supported by an assigned staff coach.
