The LifeFlight Foundation (LFF) aids in the development of Maines major air medical and critical care transport needs including infrastructure such as hospital helipads, aviation weather systems, instrument flight systems, and communication systems, the capital acquisition of specialized medical equipment and technology, the capital acquisition of medical aircraft, and the provision of continuing medical education for hospital and EMS personnel throughout Maine LFF supports the provision of emergent medical care and transportation to critically ill and injured patients by LifeFlight of Maine (LOM) LFF supports statewide continuing medical education provided by LOM to physicians, physician extenders, nurses, paramedics, and EMTS through didactic and simulation programs

The LFF supports a wide range of continuing medical education In 2013 LFF provided financial and management support for the human patient simulator project run by LOM in partnership with the Maine Department of Public Safety Emergency Medical Services Bureau The simulation program is used by hospitals and EMS agencies throughout Maine for continuing medical education to improve the care of critically ill and injured patients with a special focus on children In 2013, the HPS provided 30 programs including 5 pediatric conferences In total the continuing medical education program had 362 students including 17 physicians, 11 Nurse Practitioners/PAs, 230 RNs, 15 Respiratory Therapists and 89 Paramedics

The LFF, through a private-public partnership with the State of Maine and the Federal Aviation Administration supported aviation infrastructure including the maintenance support for 11 automated weather observation systems located at rural airports and hospitals which are used by general aviation operations and the National Weather Service, development and management of helipads at three hospitals, the maintenance of 39 helicopter instrument flight approach and departure procedures at hospitals, communities, islands, and rural airports, and aviation safety equipment used by LifeFlight
