IN THE FISCAL YEAR JULY 1, 2012 - JUNE 30, 2013, GRAFTON PROVIDED TREATMENT/SUPPORT TO THE DEVELOPMENTALLY AND INTELLECTUALLY DISABLED POPULATION TOWARD ACHIEVING THEIR PERSONAL OUTCOMES. GRAFTON SPECIALIZES IN PREVENTING INSTITUTIONALIZATION AND ENABLING INTEGRATED COMMUNITY LIVING. ITS CORE COMPETENCY IS PROVIDING 24-HOUR TREATMENT/EDUCATION TO INDIVIDUALS WHOSE BEHAVIOR IS SO CHALLENGING THAT OTHER AGENCIES HAVE REFUSED TO SERVE THEM (A SMALL NUMBER OF INDIVIDUALS RECEIVED DAY ONLY SUPPORTS). THESE INDIVIDUALS WERE DIAGNOSED AS HAVING AUTISM, MENTAL RETARDATION, PSYCHIATRIC DISORDERS, LEARNING DISABILITIES, SEIZURE DISORDERS, AND SENSORY AND PHYSICAL CHALLENGES - ALMOST ALL WITH SOME COMBINATION OF THE ABOVE. AS AGREED TO BY THE 98 LOCAL GOVERNMENTS REFERRING THEM FROM VIRGINIA, MARYLAND, WEST VIRGINIA, AND THE DISTRICT OF COLUMBIA, GRAFTON PROVIDED RESIDENTIAL TREATMENT TO 507 CHILDREN/ADOLESCENTS AND 123 ADULTS AND EDUCATION/DAY SUPPORT TO 691 CHILDREN/ADOLESCENTS AND 76 ADULTS WITHIN THREE MAIN GEOGRAPHIC REGIONS: WINCHESTER/BERRYVILLE, VA, LEESBURG/STERLING, VA, AND RICHMOND, VA. THROUGH ITS RELATED SERVICES, GRAFTON PROVIDED OUTPATIENT BEHAVIORAL MENTAL HEALTH SERVICES TO ALL AGES IN THE LOUDOUN COUNTY, VA GEOGRAPHICAL AREA, WHICH FOCUSES ON SERVING INDIVIDUALS DEALING WITH BOTH ROUTINE AND EXTRAORDINARY CIRCUMSTANCES IN A SUPPORTIVE ENVIRONMENT. ADDITIONALLY, GRAFTON PARTNERS WITH THE CITY OF WINCHESTER TO PROVIDE SERVICES TO THE INFANT AND TODDLER CONNECTION OF THE SHENANDOAH VALLEY, AN EARLY INTERVENTION SERVICE THAT TEACHES, COACHES AND MENTORS FAMILIES OF CHILDREN UP TO AGE THREE WHO HAVE A DEVELOPMENTAL DELAY OR DIAGNOSED DISABLING CONDITION. DURING THIS FISCAL YEAR APPROXIMATELY 494 INFANTS/TODDLERS RECEIVED EARLY INTERVENTION SERVICES AND SUPPORTS IN THE CITY OF WINCHESTER, VA AND THE COUNTIES OF FREDERICK, CLARKE, WARREN, PAGE AND SHENANDOAH, VA. RECENTLY GRAFTON EXPANDED ITS RELATED SERVICES AND LAUNCHED AN APPLIED BEHAVIORAL ANALYSIS LINE OF BUSINESS THAT PROVIDES THERAPEUTIC SUPPORTS TO BEHAVIORALLY CHALLENGED CHILDREN AND THEIR FAMILIES IN THEIR HOMES OR OTHER NATURAL SETTINGS. FOR THE FISCAL YEAR, THESE SERVICES WERE PROVIDED IN FOUR MAIN GEOGRAPHICAL AREAS: SHENANDOAH VALLEY, VA, RICHMOND, VA, CHARLES TOWN/JEFFERSON COUNTY, WV, AND BRADENTON/MANATEE COUNTY, FL. ON FEBRUARY 5, 2013 GRAFTON INTEGRATED HEALTH NETWORK BECAME THE SOLE MEMBER OF GRAFTON AUSTRALIA, LTD. GRAFTON AUSTRALIA, LTD IS AN AUSTRALIAN NOT FOR PROFIT CORPORATION THAT HAS STATUS AS A PUBLIC BENEVOLENT INSTITUTION SUPPORTING INDIVIDUALS WITH INTELLECTUAL AND DEVELOPMENTAL DISABILITIES IN AUSTRALIA. SERVICES INCLUDE CONSULTATION, SUPPORT, RESEARCH, AND EDUCATION TO INDIVIDUALS WITH ID/DD DISABILITIES AND THEIR FAMILIES. IN SUPPORT OF ITS MISSION, GRAFTON EMPLOYED APPROXIMATELY 776 FULL TIME EQUIVALENT STAFF, OF WHICH APPROXIMATELY 89% ARE EMPLOYED IN THEIR CORE SERVICES (WHICH OPERATES 24-HOURS PER DAY, SEVEN DAYS PER WEEK, 365 DAYS PER YEAR).
