Explanation: Our accountant at the time said we should not file until we were reinstated as an exempt organization under 501 (c) (3). We finally received that reinstatement after transmission of the approved application which was approved on December 13, 2013. While the accountant filed an extension to February 15, 2014, we had to end our relationship with him due to non-performance. We have found a new member of the orchestra to serve on the Board and take on Treasurer responsibilities. He has had to take control of the books and do all of the accounting for the past year. We now have the data and capability to pull the financials together to complete the Form 990 for Fiscal year July 1, 2012 - June 30, 2013.
