As the knowledge and research communication arm of GDN, GDNet brings together and communicates policy-relevant research from the South and is a partner in the global drive to improve access, delivery and adoption of academic research. By convening opportunities, providing information and encouraging sharing and learning, GDNet is creating an enabling environment for southern researchers to communicate their work better and more widely. Much of GDNet's capacity building and knowledge sharing work is carried out in collaboration with regional partners within research institutes, think tanks, international donor organizations and governments.
